

The National Credit Union Foundation Board selection is based on the information provided in this Declaration of Candidacy.

The following seven seats are up for nomination – two of them (Seats 3 and 11) are appointed seats from system partners; the remaining five (Seats 6, 9, 12, 13, and 15) are open for election:

- **Seat 3** Appointed by America's Credit Unions; **Qualifications:** Must be and remain an executive officer or director of an affiliated credit union.
- Seat 6 Credit Union Executive or Director: Qualifications: Must currently be and remain an executive officer or director of a credit union.
- **Seat 9** State Credit Union Foundation Network. **Qualifications:** Must be and remain an employee of a state or regional credit union foundation or of a league that manages such a foundation and shall be appointed by the State Credit Union Foundation Network (SCUF).
- **Seat 11** Executive Officer of TruStage. **Qualifications**: Must be and remain an executive officer of TruStage and shall be appointed by TruStage.
- **Seat 12** Director or Executive Officer of a national organization. **Qualifications:** Must be and remain a director or executive officer of an organization that is national in scope, that has as its primary purpose support of credit unions or some element of the credit union movement, that has a significant portion of its ownership or membership from the credit union system and that has demonstrated a commitment to the purposes of the Foundation.
- **Seat 13** Credit union executive or director or system affiliate or at-large. **Qualifications:** Must be and remain (i) an executive officer or director of a credit union, or (ii) a director or executive officer of an organization that is national in scope, that has as its primary purpose support of credit unions or some element of the credit union movement, that has a significant portion of its ownership or membership from the credit union system and that has demonstrated a commitment to the purposes of the Foundation, or (iii) a representative of an organization outside of the credit union system that has demonstrated a commitment to the



purposes of the Foundation ("At-large"). No more than two (2) of seats 13-17 may be "At Large" representatives.

• **Seat 15** -- Credit union executive or director or system affiliate or at-large. **Qualifications:** Must be and remain (i) an executive officer or director of a credit union, or (ii) a director or executive officer of an organization that is national in scope, that has as its primary purpose support of credit unions or some element of the credit union movement, that has a significant portion of its ownership or membership from the credit union system and that has demonstrated a commitment to the purposes of the Foundation, or (iii) a representative of an organization outside of the credit union system that has demonstrated a commitment to the purposes of the Foundation ("At-large"). No more than two (2) of seats 13-17 may be "At Large" representatives.

Other Eligibility Requirements

No current employee of America's Credit Unions and its affiliate organizations (including The National Credit Union Foundation) or their family members shall be eligible for a Foundation board position. No former employee of America's Credit Unions and its affiliate organizations or their family members, shall be eligible for a Foundation board position for six years from the date of last employment. "Family" shall be defined as spouse, parent, child, sibling, uncle/aunt, niece/nephew, grandparent, grandchild, or any of those or equivalent relationships arising as the result of marriage, civil union or domestic partnership.

Nominations must be received by October 25, 2024.

Baselines: The following baseline criteria will be used to assess candidates:

- How will the candidate contribute to the ultimate achievement of the National Credit Union Foundation's mission and vision?
- Individuals with specific experience in fundraising and nonprofit success may be targeted in recruitment. To that end, what specific skills does the candidate bring to the table (e.g., fundraising, program experience, contacts) that enhances her/his ability to support the Foundation?



Fundraising

The Foundation Board is primarily a fundraising board. Board members are expected to donate personally and solicit donations from their organizations and others to support the Foundation's work as follows: (i) Board members traditionally give personal gifts between \$100 and \$5,000 annually to the Foundation; and (ii) Board members also are responsible for contributions from their own organizations and others. Please see the suggested giving levels below:

| Credit Union Asset Size | Suggested Donation |
|-------------------------|--------------------|
| More than \$5B | \$25,000 |
| \$1B - \$4.9B | \$10,000 |
| \$501M - \$999M | \$5,000 - \$10,000 |
| \$250M - \$500M | \$2,500 - \$5,000 |
| Less than \$250M | \$1,000 - \$2,500 |

Affiliation:

The candidate's employing or sponsoring entity is required to be an affiliate in good standing with America's Credit Unions for a candidate's ability to serve as a director.

Diversity:

The Foundation Board is committed to creating a diverse board while maintaining the ultimate goal of securing excellent candidates. Diversity encompasses all the characteristics, experiences and cultural influences that make each person unique. The collective sum of the individual differences, life experiences, knowledge, inventiveness, innovation, self-expression, unique capabilities and talent plays a significant part in the strength of the Foundation Board.

<u>Leadership</u>:

The Foundation Board is committed to the development of new leadership and the strengthening of alliances with different sectors of the credit union system. The Foundation Board views the annual nominations and elections process as an opportunity to fulfill this commitment.
